Venue: This year's one-day ADULT Co-Ed Southeast Tournament will be held at the Roland Park Country School at 5204 Roland Ave, Baltimore MD 21210. The facility has two **artificial turf** fields; however 1 field is significantly smaller than the other field. Please be aware of this. We will still be playing 11 v 11 on this field.

Participants: All participants must be 18 or older. Two male field players are allowed at one time. Exception: Teams may only play with one male field player when the opponent has no male player(s) on their roster. Goalie is neutral and can be of either gender.

Team Fee: \$450

Registration: To register, please complete the following (postmarked on or before **October 31, 2014**):

- 1) **E-mail** a copy of the completed registration form to **Tracey Moher** at [tracey.moher@gmail.com](mailto:tracey.moher@gmail.com). This temporarily holds a spot for your team.
- 2) **Mail** the following to **Kerry Hospelhorn** (see address on registration form)
  - a. \$450 team fee (checks made out to BFHA), and
  - b. SEPARATE \$50 refundable forfeit fee, and
  - c. Signed Registration Form

Teams are accepted in the order in which the completed registration form is received via EMAIL by Tracey Moher. However, if your check is not received by Kerry Hospelhorn with a postmark on or before October 31<sup>st</sup>, your team will forfeit its spot or be charged an additional \$25 late fee. We MUST receive the full fee to permanently hold your team's spot. So to guarantee your spot please send in your registration ASAP!!

Late Registration: There will be a late registration deadline of **November 7, 2014** for teams who do not mail ALL 3 registration requirements by the October 31, 2014 deadline. An additional \$25 non-refundable late fee will be charged if a team would like to keep its spot for the tournament. The late fee along with the other requirements must be postmarked by November 7, 2014. Teams that have failed to complete late registration will be dropped from the tournament. We will not accept any registrations and no refunds will be issued after November 7, 2014.

Rosters: Team rosters should be submitted by **November 7, 2014**. The final team roster must be submitted before the team's first game on November 15<sup>th</sup>. No changes are allowed after the final roster is submitted and play has started. A player may not play on multiple teams. Include USFHA membership # for all players.

Cancellation Policy: BFHA reserves the right to modify game schedules and times based on weather or other conditions. The tournament will be cancelled if the weather is judged hazardous (tournament will go on in rainy weather, but lightning policy applies) to players' safety or if there is a local emergency.
